PARKS & FACILITIES

FCCA parks & facilities are open to residents on a first-come, first-serve basis. Residents may pick up a key for access to the FCCA tennis courts at the main office (4350 Austin Parkway). A \$15 deposit is required.

AQUATIC CENTER (40 acres)

4350 Austin Parkway – Contains a playground, spray park (spring/summer operation), a 50-meter pool, 2 lighted volleyball courts, disc golf course, picnic tables, 23-acre lake, walking trails, drinking fountain, and benches.

CREEKSHIRE (0.70 acres) – 1907 Creekshire

Contains a lighted tennis court and a neighborhood pool with a climbing wall. Adjacent to City of Sugar Land's Lost Creek Park, which contains soccer fields, playground, pavilion, and community building. For more information about Lost Creek Park, please call (281) 275-2885.
